By this declaration, the undersigned company DATEXEL S.r.l. guarantees that all of the devices of its own production are in compliance to the current existing rules with regard to environment safety and protection of the health of the involved operators.

Directive RoHS (Restriction of Hazardous Substances in Electrical and Electronic Equipment)

With reference to the Directive 2011/65/EU (RoHS2) and to its Delegated Directive 2015/863/EU (RoHS3) about the restriction of use of hazardous substances in electric and electronic equipment (RoHS), the undersigned company DATEXEL S.r.l. declares that its products are in compliance with the limits established by the Annex II.

- Diisobutyl phthalate (DIBP): < 1000 ppm

DATEXEL S.r.l. declares that, based upon its own knowledge and the information received from its suppliers, in the products sold is not contained any of the substances identified as extremely concerning (SVHC, Substances of Very High Concern) or included in the Annex XIV of the REACH Regulation in a percentage of weight higher than 0.1 %.
